The Regents of the University of Minnesota (hereinafter "University"), to secure registration of copyright in the volume cited above, requests that the Contributor (hereinafter "You" or "you") grant to the University certain nonexclusive rights to your essay. You also agree to have your essay distributed as part of an Open Access website to be developed and maintained by the University and to have your essay distributed under a Creative Commons Attribution-Noncommercial-NoDerivatives license.

## I. PUBLICATION

The University agrees to publish the volume for which your essay has been selected. You agree that publication of your essay is contingent upon its final acceptance by the volume editor and the University. You warrant that your essay is your original work and agree to inform the University of any previous publication.

## 2. WARRANTY

You represent that you are the sole owner of your essay; that it does not infringe any copyright; that to the best of your knowledge your essay contains no matter that is libelous or otherwise unlawful; and that it makes no unlawful invasion of privacy.

## 3. DELIVERY

You agree to deliver your contribution, which shall consist of no more than **40** double spaced pages, including notes and references, to the volume editor by **May 1, 2011.** 

## 4. **PERMISSIONS**

You agree that you will obtain any necessary permissions for use of the text or illustrations whose use is controlled by others; that you will have paid any resulting permissions fees; and that you will give the University copies of documents granting all permissions.

## 5. GRANT OF RIGHTS

You grant to the University the nonexclusive right to reproduce your essay and distribute it by all means and media now known or hereafter discovered. The nonexclusive rights you grant to the University include, but are not limited to: original publication throughout the world in all languages; anthology; serial; digest; abridgment; condensation; adaptation; translation; dramatizations; photocopying; microfilm; reprint editions by other publishers; electronic media versions; display and transmission publicly or otherwise on-line, or through other electronic or digital means of transmission; and the right to copyright the volume in the name of the volume editor.

#### 6. **RIGHT TO REPRINT**

You retain the right to reprint your essay in subsequent collections or as a part of a larger original work written by you, with acknowledgment of its original publication in the volume cited above.

### 7. CONTRIBUTOR'S COPIES

The University will send you two (2) complimentary copies of the paperback edition of the published volume. You may purchase additional copies at contributor's discount of forty percent (40%) from the list price.

#### 8. APPLICABLE LAWS

Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, will be resolved in accordance with the Minnesota Uniform Arbitration Act, and the decision of the arbitrators shall be final and binding upon all parties. This Agreement and the performance thereof, irrespective of the place of its execution, delivery, or performance, shall be interpreted in accordance with the laws of the State of Minnesota.
